*To the Commissioner of Patents:*

Edw. K. Tryon Company, a corporation duly organized under the laws of the State of Pennsylvania and located at Philadelphia, Pennsylvania, and doing business at 817-819 Arch Street, Philadelphia, Pennsylvania, has adopted and used the trade-mark shown in the accompanying drawing, for ARTIFICIAL BAITS, BAIT AND MINNOW PAILS, BAIT AND TACKLE BOXES, BALANCES, BASS CASTING SINKERS, CHUGGING RIGS, CORK BALLS, CRAB TRAPS, DOCK BELLS, FEATHERED JIGS, FISH BAGS, FISH FINDERS, FISH SPEARS, FISH STRINGERS, FISH TONGS, FISHING FLOATS, FISHING LEADERS, GUT AND WIRE, FISHING LINES, FISHING NETS, FISHING REELS, FISHING RODS, FISHING ROD BUTT CAPS, FISHING ROD FERRULES, FISHING ROD GUIDES, FISHING ROD REEL SEATS, FISHING ROD TIPS, FISHING ROD WINDING CHECKS, FLIES, FLY AND TACKLE BOOKS, FROG HARNESS, FROG SPEARS, GAFFS, MINNOW TRAPS, MOUTH OPENERS, NET FRAMES, REEL CLAMPS, RINGER SINKERS, ROD STANDS, RUBBER ROD BUTTS, SAFETY SNAPS, SAND SPIKES, SILKWORM GUT, SINKERS, SNAPS AND RINGS, SNEELED HOOKS FOR FISHING, SPLIT RINGS, SPLIT SHOT, SPREADERS, SWIVELS, TIPPETS, AND WADERS, in Class

22, Games, toys, and sporting goods, and presents herewith five specimens showing the trade-mark as actually used by the applicant upon the goods, and requests that the same be registered in the United States Patent Office in accordance with the act of February 20, 1905, as amended. The trade-mark has been continuously used and applied to said goods in applicant's business since June 15, 1937. The trade-mark is applied or affixed to the goods, or to the packages containing the same, by placing thereon a printed label on which the trade-mark is shown.

Applicant is the owner of registrations 318,653 of October 30, 1934; 346,101 of May 18, 1937; and 347,010 of June 15, 1937.

Applicant hereby appoints Wm. Steell Jackson and Son, a firm comprising Wm. Steell Jackson and Joseph Gray Jackson, whose postal address is 112 South 16th Street, city of Philadelphia, State of Pennsylvania, its attorneys to prosecute this application for registration, with full power of substitution and revocation, to make alterations and amendments therein, to receive the certificate and to transact all business in the Patent Office and in the courts connected therewith.
