STATEMENT

22, Games, toys, and sporting goods, and presents herewith five specimens (or facsimiles) showing the trade-mark as actually used in connection with such goods, the trade-mark being applied by printed labels affixed to the goods or containers for the goods or marked directly on the goods, and requests that the same be registered in the United States Patent Office on the Principal Register in accordance with section 2(f) of the act of July 5, 1946.

The trade-mark was first used in January, 1908 for Group A; in July, 1910 for Group B; in January, 1911 for Group C; in January, 1913 for Group D; in July, 1913 for Group E; in July, 1914 for Group F; in January, 1924 for Group F; in January, 1924 for Group G; in July, 1933 for Group H; in January, 1934 for Group I; on December 29, 1945 for Group J; on January 15, 1946 for Group K; on July 15, 1946 for Group L; on December 29, 1946 for Group M; on January 15, 1947 for Group N; on June 27, 1947 for Group O; on July 15, 1947 for Group P, and first used in commerce among the several States which may lawfully be regulated by Congress on the respective dates aforesaid. Attached hereto is a letter of permission from John Higgins, who authorized applicant's first use of the trade-mark

The mark is claimed to have become distinctive of the applicant's goods in commerce which may lawfully be regulated by Congress through substantially exclusive and continuous use thereof as a mark by the applicant in interstate commerce for the five years next preceding the date of the filing of this application.
